## DIEP RIVER / MILNERTON LAGOON YOUR REF: L9/BD/04

We hereby acknowledge receipt of your letter dated 9 July 2020 received by email.

Please find detailed below our response to your letter concerning the complex challenges faced with regard to the current state and pollution of the Diep River / Milnerton Lagoon. Please note that any failure on the part of the City to address issues raised in your letter does not indicate concurrence therewith.

In response to your letter, we reply (as per your number references) as follows:

• Ad 5:

The City's Wastewater Branch did report that OUTA's independent sampler was caught trespassing on the Potsdam Wastewater treatment plant site (Potsdam WWTW) on the afternoon of 8 July 2020 and was escorted off-site after refusing to meet with plant management in their office, so that management might protocols around access to the site to undertake water sampling. The City's staff has reported a different version of events, as per the attached incident report.

• Ad 6:

Sample point "PDA" is the outfall weir from the final pond discharging from the Potsdam WWTW on the eastern bank of the Diep River, and this can only be legally be accessed via the main entrance of the Potsdam WWTW. While sample point "PDC" can be taken from either the western or eastern bank of the Diep River, again the eastern bank can only be legally accessed via the main entrance of the Potsdam WWTW. Similarly, the **WATER & SANITATION HEAD OFFICE** 

western bank can only be legally accessed through the main entrance to the Table Bay Nature Reserve, Rietvlei Section entrance off Sandpiper Crescent in Flamingo Vlei. The fact that no signage or fencing exists should not detract from the fact that the sampler had trespassed onto City land without permission irrespective of the land registration type.



• Ad 7:

The incident report received from City personnel disagrees with the sampler's version of events. It should be noted that the Potsdam WWTW is an industrial site with strict health & safety protocols, therefore it is understandable that the works and security personnel would react decisively to finding a trespasser on the site. In fact the sampler was invited to the Plant manager's office so that the protocols to come and take samples legally could be explained to him, an offer which he declined.

• Ad 8:


The results are contradictory for sample point "PDA" as the location of the sample point with the City's FE point cannot be compared (refer to plan below).



The City understands the reason for OUTA conducting independent water tests, and also seeks to regain the public's trust and to improve the water quality in the Milnerton Lagoon and across the entire City.

• Ad 11, 12, 13 & 14:

The City is willing to accommodate OUTA with access to various sites to undertake their independent sampling and thereby ensure the health & safety of OUTA's vendors on restricted areas.
